CHAIRMAN'S STATEMENT

I hereby present the annual report and audited financial statements for Rockpool Acquisitions PLC ("**Rockpool**" or "the **Company**") for the period ended 31 March 2026. Please note that on 31 March 2026 the board decided to extend the 2025 financial year (originally due to end on 31 December 2025) so that it ended on 31 March 2026. The period covered by this annual report and audited financial statements is, therefore, the 15 months from 31 December 2024 to 31 March 2026.

During that extended financial period, the Company incurred an operating loss of £295,635 (December 2024 – profit £239,676). The loss resulted from the Company's expenditure on maintaining its listing, and its other administrative overhead as well as legal and other professional costs relating to the proposed acquisition of European Lingerie Group, AB ("**ELG**"), a company incorporated in Sweden ("the **transaction**") and the proposed re-admission ("the **re-admission**") of Rockpool's ordinary shares to the Equity Shares (Commercial Companies) category of the Official List and to the Main Market of the London Stock Exchange. Under the arrangements entered into with ELG, the Company is entitled to receive certain contributions from ELG towards its costs of the transaction and re-admission and, accordingly, an amount of £260,000 was recognised as income in the period. That amount is, however, still outstanding and is not expected to be received until ELG completes its current round of funding (as to which see below) if at all. As a result the directors have taken the decision to provide for the balance in full. As at 31 March 2026 the Company had £132,211 of cash and cash equivalents.

Trading in the Company's shares has remained suspended throughout the period under review as a result of the announcement of the transaction, made on 18th December 2024 and is not expected to re-commence until readmission or the point at which transaction is abandoned.

In connection with the transaction and the re-admission, the Company commenced preparing a draft prospectus ("the **prospectus**") and carrying out due diligence on ELG and its subsidiaries (together, "the **ELG Group**" or "the **Group**"). That work was suspended, however, at the end of April 2025 when it became apparent that ELG was unable to make the payments due from it by way of contribution to the Company's costs and was lacking the working capital needed for it to be able to clear amounts owed to suppliers so that it could meet a substantial backlog of orders for the Group's lingerie products. No substantive work has been undertaken by the Company since then whilst we wait for ELG to be in a position to commence payments to the Company.

As I reported in my chairman's statement accompanying the accounts for the Company for the period ended 31 December 2024, the Group then commenced an asset disposal, debt reduction and debt refinancing programme as well as engaging in efficiency improvements and other initiatives. As I reported in that statement, ELG also attempted to undertake a pre-reverse takeover fundraising and appointed a broker based in Asia to assist with that. Unfortunately, even though interest was generated from a number of potential investors, that broker was ultimately unsuccessful in raising funds, with Donald Trump's so-called tariff wars apparently playing a role in deterring investors from Asia from investing in the Group. The Group was also ultimately unable to complete its planned sale and lease-back of its factory in Latvia, despite reaching advanced stages with more than one counterparty. As an alternative, the ELG Group has, however, successfully disposed of the rights to its *Felina* brand outside the United States to the company that owns a brand of the same name in that territory (and uses it for lingerie targeted at a less expensive segment of the market in the USA). As part of that deal ELG acquired a licence to use the *Felina* brand in certain territories in exchange for an annual fee. ELG Group received a substantial one-off payment for the disposal of the *Felina* brand, but the bulk of that money was retained by the Group's bankers in order to reduce the amounts overdue to it and this reduced the amount that could be put towards additional working capital for the Group.

Partly as a result of this, the Group has been undertaking a programme of cost reductions (including by means of a programme of redundancies and efficiency and cashflow enhancements in its core lingerie and fabrics production divisions, with the latter now having returned to profitability at the EBITDA level). The Group has also been undertaking a new fund-raising exercise targeting convertible debt for which it is in advanced discussions with an investor regarding the investment of an amount sufficient to allow for the re-financing or regularisation of its existing debt facilities. It also previously received a firm (although not legally binding) commitment of €3m on the basis that it raises at least a further €2m by way of matched funding from a professional investor.

If its fundraising is successful, it is anticipated that ELG will be able to make a substantial payment to Rockpool at the same time as being able to make headway towards clearing its backlog of outstanding customer orders for lingerie. At that point, or shortly thereafter, Rockpool would expect to be in a position to recommence work on the transaction and the re-admission process, targeting the first half of 2027 for completion. It is unlikely that the funding would close before the end of August 2026.

Outlook

The continued delay in progressing with the transaction and in working towards re-admission is a source of considerable frustration for the board. As a result, whilst the board remains hopeful that ELG will be able to raise sufficient funds, it has decided to look for alternative transactions with a view to pursue a suitable one should sufficient progress not be made by ELG towards completing its fundraising in the next few weeks.

The Board would like to thank shareholders, advisers and others for their continued support and considerable patience during the period under review.

The Directors present their Strategic Report for the period ended 31 March 2026.

Business Review

Rockpool Acquisitions plc (“Rockpool” or “the Company”) was incorporated on 21 March 2017 and on 12 July 2017 the Company’s share capital was admitted to what was then the Standard Segment of the Official List of the UK Listing Authority and to the Main Market of the London Stock Exchange.

Rockpool was set up as a Special Purpose Acquisition Company (“SPAC”) based in Northern Ireland and was originally formed to undertake an acquisition of a company or business headquartered or materially based in Northern Ireland. The Board has since widened its geographic scope and to consider businesses based elsewhere.

On 18th December 2024, the Company announced that it had signed heads of terms (“the **Heads of Terms**”) for the acquisition of European Lingerie Group, AB (“**ELG AB**”) (“the **transaction**”) and for the proposed re-admission (“the **re-admission**”) of Rockpool’s ordinary shares to the Equity Shares (Commercial Companies) category of the Official List and to the Main Market of the London Stock Exchange. As a result of that announcement trading in the Company’s ordinary shares was suspended pending re-admission or termination of the transaction.

Performance of the Business and Position at the End of the Financial Period

The Company reported a loss of £295,635 for the period 15-month ended 31 March 2026 (31 December 2024 – profit of £239,300). The loss resulted from the Company’s expenditure on maintaining its listing, and its other administrative overhead as well as legal and other professional costs relating to the proposed transaction and re-admission.

Net assets as at the period-end 31 March 2026 were £49,967 (31 December 2024 - £345,799), with £132,211 in cash balances held at that date (31 December 2024 - £429,294). Loans of £2,120 were outstanding at the period-end 31 March 2026 (31 December 2024 - £9,912).

Future developments

In connection with the transaction and the re-admission, the Company commenced preparing a draft prospectus (“the **prospectus**”) and carrying out due diligence on ELG AB and its subsidiaries (together, “the **ELG Group**” or “the **Group**”). That work was suspended, however, at the end of April 2025 when it became apparent that ELG AB was unable to make the payments due from it by way of contribution to the Company’s costs and was lacking the working capital needed for it to be able to clear amounts owed to suppliers so that it could meet a substantial backlog of orders for the Group’s lingerie products. No substantive work has been undertaken by the Company since then whilst the Company waits for ELG AB to be in a position to commence payments to the Company. The ELG Group has been successfully undertaking measures to reduce headcount and overhead and increase efficiency. At the same time it is in talks with a number of investors regarding the injection of funds into the Group to deal with its working capital shortfall. If those talks reach a successful conclusion within a reasonable period and ELG is able to commence payments due to the Company to cover its costs incurred and to be incurred in relation to the transaction and readmission then it is anticipated that work will recommence on the transaction and readmission. In the meantime, the Company is looking for alternative acquisition targets which could replace ELG AB if it is not successful in its fund-raising endeavours.

Key Performance Indicators ('KPIs')

The Board monitors the activities and performance of the Company on a regular basis. The primary performance indicator applicable to the Company is Return on Investment ("ROI"). Using ROI is not currently relevant because the Company is yet to complete a corporate acquisition. As noted above, it remains the intention of the Company to effect an acquisition in due course.

Given the current nature of the Company's business, the Directors are of the opinion that the primary performance indicator applicable to the Company is the completion of the planned RTO of a target company. The Directors are of the view that given the straightforward nature of the Company, there are no non-financial performance indicators at this time.

Environmental and Social Matters

The Company does not currently trade and has no employees other than the Directors. The Company has minimal environmental and social impact in its current state. The Directors will ensure that when the Company makes an acquisition, they have sufficiently considered the acquisition's potential impact on both the environment and its consideration of social corporate responsibilities and will ensure that appropriate safeguards are in place.

Principal Risks and Uncertainties

The Company operates in an uncertain environment and is subject to a number of risk factors. The Directors consider the following risk factors to be of particular relevance to the Company's activities. It should be noted that the list is not exhaustive and other risk factors not presently known or currently deemed immaterial may apply. The risk factors are summarised below:

Business Strategy

The Company has no operating history (other than the provision of consultancy services to potential targets) and has not yet acquired a business. The Company may not be able to complete the acquisition of ELG AB in a timely manner or at all, and if it does not it may not be able to find a suitable alternative target and/or meet the costs of acquiring an alternative target business or fund the operations of such an alternative if it does not obtain additional funding. If the Company acquires less than either the whole voting control of, or less than the entire equity interest in, a target company or business, its ability to influence the strategy of the target may be limited and third-party minority shareholders may dispute any strategy the Company may have decided to pursue.

European Lingerie Group AB

ELG AB is suffering from a shortage of working capital, and its group is in default of its main debt facility as well as its obligations to the Company to make monthly payments by way of contribution to the costs the Company has incurred in respect of the transaction and readmission ("the Costs"). If ELG AB fails to successfully complete its current fundraising in a timely manner, or at all, then ELG AB may not be able to continue in operation, or may lack funds to make the required contributions to the costs being incurred by Rockpool in connection with the re-admission and the transaction, or its ability to achieve the levels of

financial performance needed to make the re-admission fundraising a success may be adversely affected, and, as a consequence, re-admission and completion of the transaction may accordingly be delayed or abandoned. The Company is entitled, on termination by it for breach by of ELG AB's obligations to make costs payments to the Company, to be indemnified by ELG AB in respect of all the Costs together with certain of its overhead expenditures together with interest. If, however, ELG AB is unable to successfully complete its fundraising it may be unable to fund the required indemnity payments. In that case the Company may, even if it terminates the transaction, be left with insufficient funds to enable it to operate for a sufficient time to find an alternative target for acquisition that has the funds to meet the costs of the acquisition of that target by the Company and of the associated re-admission to the Main Market.

Funding an Acquisition

As noted, above, if the Company is unable to complete the transaction (either because it terminates the transaction on the grounds of breach by ELG AB of its obligations, or otherwise), further funds are likely to be needed in order to complete the acquisition of an alternative target business once it has been identified. If the chosen alternative target is not able to provide those funds, the Company will need to seek additional equity or debt financing to complete its acquisition and re-admission and there is a substantial risk that it will be unsuccessful in attempting to do so.

Iran Conflict

The on-going conflict in the Middle East has had an adverse effect on oil and gas prices and interruptions to the supply of various commodities and is likely to cause a short to medium-term reduction in economic activity in ELG Group's key markets (if not a world-wide recession) and to lead to increased costs in ELG Group's supply chains. This may in turn lead to erosion of the Group's margins, and to reduced consumer appetite for the type of upmarket lingerie that the ELG Group specialises in producing, as well as for the other lingerie brands that currently acquire fabrics from the Group. Thus, the enlarged Group's trading prospects may be adversely affected, especially if the conflict is not resolved in the near future. The conflict may also affect the ability of the Company to raise funds at re-admission.

Retention of Key Personnel

The Company is dependent on the Directors to pursue the acquisition of the ELG AB and manage the acquisition and re-admission process and, if that acquisition is not completed, to assess potential acquisition opportunities that have been identified by the Directors. The loss of the services of any of the Directors could materially adversely affect its ability to implement its business strategy, thereby having a material adverse effect on its financial condition and result of operations.

Section 172 Statement

Section 172 (1) of the Companies Act 2006 obliges the Directors to promote the success of the Company for the benefit of the Company's members as a whole. This section specifies that the Directors must act in good faith when promoting the success of the Company and in doing so have regard (amongst other things) to:

- a. the likely consequences of any decision in the long term,
- b. the interests of the Company's employees,
- c. the need to foster the Company's business relationship with suppliers, customers and others,
- d. the impact of the Company's operations on the community and environment,
- e. the desirability of the Company maintaining a reputation for high standards of business conduct, and
- f. the need to act fairly as between members of the Company.

The Board of Directors is collectively responsible for formulating the Company's strategy, which is to identify an acquisition of a company or business which is profitable at the EBITDA level and, whilst, ideally, being headquartered or materially based in Northern Ireland, could be based in any region of the world.

The Board places equal importance on all shareholders and strives for transparent and effective external communications, within the regulatory confines of a main market listed company. The Directors present their report and the audited financial statements for the 15-month financial period ended 31 March 2026.

Principal Activity

Rockpool is a Special Purpose Acquisition Company based in Northern Ireland whose shares were admitted to what was then the Standard Segment of the official list and to trading on the Main Market on 12 July 2017. The Company was formed to undertake an acquisition of a company or business headquartered or materially based in Northern Ireland with a valuation of up to £20 million. It has now widened the search to consider companies based elsewhere and with higher valuations.

Directors' Indemnities

There was no directors' indemnity insurance during the period ended 31 March 2026 (31 December 2024 - £Nil).

Future Developments

Information regarding the likely future developments of the Company is included within the Strategic Report and is incorporated into this Directors' Report by cross-reference.

Events after the End of the Reporting Period

There have been no significant events since the end of the reporting period.

Dividends

No dividend was paid during the period (period ended 31 December 2024 - £Nil) and the Directors do not recommend payment of a final dividend (period ended 31 December 2024 - £Nil).

Corporate Governance

As a Company listed on the Equity Shares (shell companies) category of the Official List, the Company is not required to comply with the provisions of the UK Corporate Governance Code.

The Company has chosen, so far as appropriate given the Company's size and the constitution of the Board, to comply with the Corporate Governance Guidelines for Small and Mid-Size Quoted Companies ("the Guidelines") published by the Quoted Companies Alliance (QCA):

The Company has deviated from the Guidelines in the following respects:

- Given the size of the Board and the Company's current size, certain provisions of the Guidelines (in particular the provisions relating to the composition of the Board and the division of responsibilities), are not being complied with by the Company as the Board considers these provisions to be inapplicable.
- Until a suitable acquisition is completed the Company will not have separate risk, nomination or remuneration committees. The Board as a whole will instead review risk matters, as well as the Board's size, structure and composition and the scale and structure of the Directors' fees, taking into account the interests of shareholders and the performance of the Company.
- The Board do not consider an internal audit function to be necessary for the Company at this time due to the limited number of transactions.

The Directors are responsible for internal control in the Company and for reviewing effectiveness. Due to the size of the Company, all key decisions are made by the Board. The Directors have reviewed the effectiveness of the Company's systems during the period under review and consider that there have been no material losses, contingencies or uncertainties due to weaknesses in the controls. Details of the Company's business model and strategy are included in the Chairman's Statement and Strategic Report.

Corporate Governance (continued)

Composition and Role of the Board

The Board consists of Mike Irvine, Neil Adair and Richard Beresford and sets the Company's strategy, ensuring that the necessary resources are in place to achieve the agreed priorities. It is accountable to shareholders for the creation and delivery of long-term shareholder value. To achieve this, the Board directs and monitors the Company's affairs within a framework of controls which enable risk to be assessed and managed effectively.

Board Meetings

Given the limited activities of the Company in the period under review, the Board has met infrequently and conference calls are arranged to consider matters which require decisions or discussions.

Conflicts of interest

A Director has a duty to avoid a situation in which he has, or can have, a direct or indirect interest that conflicts, or possibly may conflict with the interests of the Company. The Board has satisfied itself that there is no compromise to the independence of those Directors who have appointments on the Boards of, or relationships with, companies outside of the Company. The Board requires Directors to declare all appointments and other situations which could result in a possible conflict of interest.

Audit Committee

The Audit Committee reviews and reports to the Board on the effectiveness of the system of internal control. Given the size of the Company and the relative simplicity of the systems, the Board considers that there is no current requirement for an internal control function. The procedures that have been established are considered appropriate for a Company of its size. The Audit Committee currently comprises Mike Irvine, who is the chair, and Neil Adair.

Carbon and Greenhouse Emissions

The Company currently has no trade, no employees other than the Directors and does not have any dedicated office space, therefore the Company has minimal carbon or greenhouse gas emissions and it is not practical to obtain emissions data at this stage. It does not have responsibility for any emission-producing sources under Companies Act 2006.

Financial Risk Management

The Company has a simple capital structure and its principal financial asset is cash. The Company has no material exposure to market risk and the Directors manage its exposure to liquidity risk by maintaining adequate cash reserves.

Report on the audit of the financial statements

Opinion

We have audited the financial statements of Rockpool Acquisitions plc (the “Company”), which comprise the statement of comprehensive income, statement of financial position, statement of changes in equity and statement of cashflows for the period ended 31 March 2026, and the related notes to the financial statements, including the material accounting policy information.

The financial reporting framework that has been applied in the preparation of the financial statements is applicable law and UK-adopted international accounting standards (UK-adopted IAS).

In our opinion, Rockpool Acquisitions plc's financial statements:

- give a true and fair view in accordance with UK-adopted IAS of the assets, liabilities and financial position of the Company as at 31 March 2026 and of its financial performance and cash flows for the year then ended; and
- have been properly prepared in accordance with the requirements of the Companies Act 2006.

Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (UK) ('ISAs (UK)') and applicable law. Our responsibilities under those standards are further described in the 'Responsibilities of the auditor for the audit of the financial statements' section of our report. We are independent of the Company in accordance with the ethical requirements that are relevant to our audit of the financial statements in the United Kingdom, including the FRC's Ethical Standard and the ethical pronouncements established by Chartered Accountants Ireland, applied as determined to be appropriate in the circumstances for the entity. We have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Conclusions relating to going concern

In auditing the financial statements, we have concluded that the directors' use of going concern basis of accounting in the preparation of the financial statements is appropriate. Our evaluation of the validity of the directors' assessment of the Company's ability to continue to adopt the going concern basis of accounting included:

- We discussed with management their budgeting process, assessing and challenging the key assumptions used by management in prospective financial information, namely budgets and forecasts which covered at least 12 months from date of approval of financial statements. In particular we carried out an analysis on the key assumptions within the model to determine the level of working capital head room available for the Company under normal trading conditions;
- We compared budgeted financial results to actual financial results for the current period to critically assess management's point of estimate; and
- We reviewed post period end results and bank statements to verify that there was no unusual or material cash outflows after the period end which had not been considered as part of management's budget review.

Based on the work we have performed, we have not identified any material uncertainties relating to events or conditions that, individually or collectively, may cast significant doubt on the Company's ability to continue as a going concern for a period of at least twelve months from the date when the financial statements are authorised for issue.

Our responsibilities and the responsibilities of the directors with respect to going concern are described in the relevant sections of this report.

Key audit matters

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the financial statements of the current financial period and include the most significant assessed risks of material misstatement (whether or not due to fraud) we identified, including those which had the greatest effect on: the overall audit strategy, the allocation of resources in the audit, and the directing of efforts of the engagement team. These

matters were addressed in the context of our audit of the financial statements as a whole, and in forming our opinion thereon, and therefore we do not provide a separate opinion on these matters.

Overall audit strategy

We designed our audit by determining materiality and assessing the risks of material misstatement in the financial statements. In particular, we looked at where the directors made subjective judgements, for example, in respect of significant accounting estimates that involved making assumptions and considering future events that are inherently uncertain. We also addressed the risk of management override of internal controls, including evaluating whether there was any evidence of potential bias that could result in a risk of material misstatement due to fraud.

Based on our considerations as set out below, our areas of focus included:

- Management override of control

How we tailored the audit scope

The Company has been set up with the principal activity being that of a special purpose acquisition vehicle to facilitate the reverse acquisition of a larger trading business. We tailored the scope of our audit, taking into account the areas where the risk of misstatement was considered material to the Company, taking into account the nature of the Company's business and the industry in which it operates. We performed an audit of the complete financial information of the Company.

In establishing the overall approach to our audit, we assessed the risk of material misstatement at a Company level, taking into account the nature, likelihood and potential magnitude of any misstatement. As part of our risk assessment, we considered the control environment in place at Rockpool Acquisitions plc.

Materiality and audit approach

The scope of our audit is influenced by our application of materiality. We set certain quantitative thresholds for materiality. These, together with qualitative considerations, such as our understanding of the entity and its environment, the history of misstatements, the complexity of the Company and the reliability of the control environment, helped us to determine the scope of our audit and the nature, timing and extent of our audit procedures and to evaluate the effect of misstatements, both individually and on the financial statements as a whole.

Based on our professional judgement, we determined materiality for the Company financial statements as a whole to be £4,000 (year ended 31 December 2024: £5,000) for the period ended 31 March 2026, determined as being 1% of total assets (year ended 31 December 2024: 1%). We have applied this benchmark because the main objective of the Company is that of a special purpose acquisition vehicle to facilitate the reverse acquisition of a larger trading business.

We have set Performance materiality for the Company at £3,000 (year ended 31 December 2024: £4,000), having considered the risk of misstatements in prior years, business risks and fraud risks associated with the entity and its control environment. This is to reduce to an appropriately low level the probability that the aggregate of uncorrected and undetected misstatements in the financial statements exceeds materiality for the financial statements as a whole.

We agreed with the audit committee that we would report to them misstatements identified during our audit above 5% of overall materiality.

Significant matters identified

The risks of material misstatement that had the greatest effect on our audit, including the allocation of our resources and effort, are set out below as significant matters together with an explanation of how we tailored our audit to address these specific areas in order to provide an opinion on the financial statements as a whole. This is not a complete list of all risks identified by our audit.

Management override of control – financial statement level risk

Description of significant matter	Our audit approach
Under ISA (UK) 240 “The Auditor’s responsibility to consider fraud in an audit of financial statements”, there is a presumed significant risk of management override of internal controls. The primary responsibility for the prevention and detection of fraud rests with management. They are responsible for establishing a robust system of internal control designed to support the achievement of policies, aims and objectives and to manage the risks facing the entity; this includes the risk of fraud. Our audit is designed to provide reasonable assurance that the financial statements as a whole are free from material misstatement, whether caused by fraud or error. Based on the operations, aims and objectives of the company, we have determined that this area requires significant auditor attention. Details on the basis of preparation of the financial statements can be found in Note 2.	Our procedures included, but not limited to: • We obtained an understanding and evaluated the design and implementation of key controls for the detection and prevention of fraud and error; • We extracted source documentation which included trial balances and nominal ledgers, and reconciling this source material to the opening and closing financial information; • We applied professional skepticism when selecting a sample of journal entries to test, which has a direct correlation to where we have assessed the key risks in respect of fraud and includes our assessment of management override of control. • We incorporated elements of unpredictability when selecting items for testing and also placed focus upon significant unusual transactions which would appear to be outside the normal course of business. We obtained supporting documentation and evidence of authorisation and review; • We enquired with management about the risks of fraud and the controls put in place to address those risks, as well as inappropriate or unusual activity; and • We performed an assessment of whether the financial results and accounting records include any significant or unusual transactions which were not in line with UK-adopted IAS. We completed our planned audit procedures, with no exceptions noted.

Other information

Other information comprises information included in the annual report, other than the financial statements and our auditor’s report thereon, including the Directors’ Report, the Strategic Report and Remuneration Report. The directors are responsible for the other information. Our opinion on the financial statements does not cover the other information and, except to the extent otherwise explicitly stated in our report, we do not express any form of assurance conclusion thereon.

In connection with our audit of the financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the audit, or otherwise appears to be materially misstated. If we identify such material inconsistencies in the financial statements, we are required to determine whether there is a material misstatement in the financial statements or a material misstatement of the other information. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact.

We have nothing to report in this regard.

Opinions on other matters prescribed by the Companies Act 2006

In our opinion, based on the work undertaken in the course of the audit:

- the information given in the Strategic Report and the Directors’ Report for the financial year for which the financial statements are prepared is consistent with the financial statements; and

In the light of the knowledge and understanding of the company and its environment obtained in the course of the audit, we have not identified any material misstatements in the Strategic Report and the Directors' Report. We have nothing to report in respect of the following matters where the Companies Act 2006 requires us to report to you if, in our opinion:

- adequate accounting records have not been kept, or returns adequate for our audit have not been received from branches not visited by us; or
- the financial statements and the part of the directors' remuneration report to be audited are not in agreement with the accounting records and returns; or
- certain disclosures of directors' remuneration specified by law are not made; or
- we have not received all the information and explanations we require for our audit.

Explanation as to what extent the audit was considered capable of detecting irregularities, including fraud

We design procedures in line with our responsibilities, outlined above, to detect material misstatements in respect of irregularities, including fraud. Owing to the inherent limitations of an audit, there is an unavoidable risk that material misstatement in the financial statements may not be detected, even though the audit is properly planned and performed in accordance with the ISAs (UK). The extent to which our procedures are capable of detecting irregularities, including fraud is detailed below.

Based on our understanding of the Company and industry, we identified that the principal risks of non-compliance with laws and regulations related to London Stock Exchange Listing Rules, Financial Conduct Authority Handbook of Rules and Guidance and Data Privacy law, and we considered the extent to which non-compliance might have a material effect on the financial statements. We also considered those laws and regulations that have a direct impact on the preparation of the financial statements such as the Companies Act 2006 and UK tax legislation. The Audit engagement partner considered the experience and expertise of the engagement team to ensure that the team had appropriate competence and capabilities to identify or recognise non-compliance with the laws and regulation. We evaluated management's incentives and opportunities for fraudulent manipulation of the financial statements (including the risk of override of controls), and determined that the principal risks were related to posting inappropriate journal entries to manipulate financial performance and management bias through judgements and assumptions in significant accounting estimates, in particular in relation to significant one-off or unusual transactions.

We apply professional scepticism through the audit to consider potential deliberate omission or concealment of significant transactions, or incomplete/inaccurate disclosures in the financial statements.

In response to these principal risks, our audit procedures included but were not limited to:

- enquiries of management board of directors on the policies and procedures in place regarding compliance with laws and regulations, including consideration of known or suspected instances of non-compliance and whether they have knowledge of any actual, suspected or alleged fraud;
- inspection of the Company's regulatory and legal correspondence and review of minutes of directors' meetings during the year to corroborate enquiries made;

- review of the financial statement disclosures to underlying supporting documentation and enquiries of management.

1. General Information

Rockpool Acquisitions plc is a public company limited by shares, incorporated and domiciled in Northern Ireland. The address of the Company's registered office is c/o Cordovan Capital Management, Suite 204, The Kelvin, 17 College Square East, Belfast, Northern Ireland, United Kingdom, BT1 6DE. The principal activity of the Company is that of a Special Purpose Acquisition Vehicle.

2. Material Accounting Policy Information

The principal Accounting Policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all the periods presented, unless otherwise stated.

a) Basis of Preparation of Financial Statements

The financial statements have been prepared in accordance with the requirements of the Companies Act 2006. The financial statements have also been prepared under the historical cost convention.

The preparation of financial statements in conformity with UK-adopted IAS requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the Company's Accounting Policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the financial statements, are disclosed.

The financial statements are presented in Pound Sterling (£). Pound Sterling is the functional and presentational currency of the Company.

New Standards, amendments or interpretations

Newly adopted standards

(a) New standards and amendments to existing standards effective 1 January 2025

There are no standards, amendments to standards or interpretations that are effective for annual periods beginning on 1 January 2025 that have a material effect on the financial statements of the Group.

(b) New standards, amendments and interpretations effective after 1 January 2025 and that have not been early adopted

A number of new standards, amendments to standards and interpretations are effective for annual periods beginning after 1 January 2025, and have not been early adopted in preparing these financial statements. The Group's assessment of the impact of these new standards and amendments is set out below:

- Amendments to the Classification and Measurement of Financial Instruments – Amendments to IFRS 9 and IFRS 7 (effective for annual periods beginning on or after 1 January 2026)

The IASB issued targeted amendments to IFRS 9 and IFRS 7 to respond to recent questions arising in practice, and to include new requirements not only for financial institutions but also for corporate entities. Among other amendments, the IASB clarified the date of recognition and derecognition of some financial assets and liabilities, with a new exception for some financial liabilities settled through an electronic cash transfer system.

a) Going concern

The preparation of financial statements requires an assessment on the validity of the going concern assumption.

At the time of approving the financial statements, the Directors have a reasonable expectation that the company has adequate resources to continue in operational existence for a period of at least 12 months from the date of approval of these financial statements due to the ongoing financial support of the directors. Thus the Directors continue to adopt the going concern basis of accounting in preparing the financial statements.

c) **Financial Instruments**

Financial assets

Financial assets, comprising trade and other receivables and cash and cash equivalents, are measured at amortised cost. They are initially recognised at fair value plus transactions costs that are directly attributable to their acquisition or issue and are subsequently carried at amortised cost using the effective interest rate method, less provision for impairment under the expected credit loss model.

The classification depends on the business model for managing the financial assets and the contractual terms of the cash flows. Financial assets are measured at amortised cost only if both of the following criteria are met:

- The asset is held within a business model whose objective is to collect contractual cash flows; and
- The contractual terms give rise to cash flows that are solely payments of principal and interest.

The amount of the expected credit loss is measured as the difference between all contractual cash flows that are due in accordance with the contract and all the cash flows that are expected to be received (i.e., all cash shortfalls), discounted at the original effective interest rate (EIR).

The carrying amount of the asset is reduced through use of allowance account and recognition of the loss in the Statement of Comprehensive Income. Allowances for credit losses on financial assets are assessed collectively. Collectively assessed impairment allowances cover credit losses inherent in portfolios of financial assets with similar credit risk characteristics when there is objective evidence to suggest that they contain impaired financial assets, but the individual impaired items cannot yet be identified.

In assessing collective impairment, the Company uses information including historical trends in the probability of default, timing of recoveries and the amount of expected loss, adjusted for management's judgement as to whether current economic and credit conditions are such that the actual losses are likely to be greater or less than suggested by historical evidence. Default rates, loss rates and the expected timing of future recoveries are regularly benchmarked against actual outcomes to ensure that they remain appropriate.

IFRS 9 suggests the use of reasonable forward-looking information to enhance ECL models. The Company incorporates relevant forward-looking information into the loss provisioning model.

Financial liabilities

Financial liabilities, comprising trade and other payables, are held at amortised cost.

Trade and other payables are recognised initially at fair value, and subsequently measured at amortised cost using the effective interest method.

De-recognition of Financial Instruments

i. Financial Assets

A financial asset is derecognised where:

- the right to receive cash flows from the asset has expired;
- the Company retains the right to receive cash flows from the asset, but has assumed an obligation to pay them in full without material delay to a third party under a pass-through arrangement; or
- the Company has transferred the rights to receive cash flows from the asset, and either has transferred substantially all the risks and rewards of the asset or has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

ii. Financial Liabilities

A financial liability is derecognised when the obligation under the liability is discharged or cancelled or expires.

d) Cash and Cash Equivalents

Cash and cash equivalents comprise current and deposit balances with banks and similar institutions. This definition is also used for the Statement of Cash Flows.

The Company considers the credit ratings of banks in which it holds funds in order to reduce exposure to credit risk. The Company will only keep its holdings of cash and cash equivalents with institutions which have a minimum credit rating of 'AA'.

e) Taxation

Income tax represents the sum of current tax and deferred tax.

Current tax

Current tax is the tax currently payable based on the taxable result for the period. Tax is recognised in profit or loss, except to the extent that it relates to items recognised in other comprehensive income or recognised in equity. In this case, the tax is also recognised in other comprehensive income or directly in equity, respectively.

Current tax is calculated at the tax rates (and laws) that have been enacted or substantively enacted at the Statement of Financial Position date.

Deferred tax

Deferred tax is recognised using the liability method in respect of temporary differences arising from differences between the carrying amount of assets and liabilities in the Financial Statements and the corresponding tax bases used in the computation of taxable profit or loss. Deferred tax liabilities are generally recognised for all taxable temporary differences and deferred tax assets are recognised to the extent that it is probable that taxable profits will be available against which deductible temporary differences can be utilised.

Deferred tax assets and liabilities are offset when there is a legally enforceable right to offset current tax assets against current tax liabilities and when the deferred tax assets and liabilities relate to income taxes levied by the same taxation authority on either the same taxable entity or different taxable entities where there is an intention to settle the balances on a net basis.

Deferred tax is calculated at the tax rates that have been enacted or substantively enacted at the Statement of Financial Position date and are expected to apply to the period when the deferred tax asset is realised or the deferred tax liability is settled.

f) Segmental reporting

The Chief Operating Decision Maker (CODM) is considered to be the Board of Directors. They consider that the Company operates in a single segment of identifying and assessing acquisition targets, which is the only activity the Company is involved in and is therefore considered as the only operating/reportable segment. As a result, the financial information of the single segment is the same as set out in the statement of comprehensive income, statement of financial position, statement of changes in equity and Statement of Cash Flows.

g) Equity

Equity comprises the following:

- Share capital represents the nominal value of the equity shares;
- Share premium represents the consideration less nominal value of issued shares and costs directly attributable to the issue of new shares;
- Retained deficit represents cumulative net profits and losses recognised in the statement of comprehensive income.

h) Financial Risk Management

Financial Risk Factors

The Company's activities expose it to a variety of financial risks: credit risk and liquidity risk. The Company's overall risk management programme seeks to minimise potential adverse effects on the Company's financial performance. None of these risks are hedged.

The Company has no foreign currency transactions or borrowings, so is not exposed to market risk in terms of foreign exchange risk or interest rate risk.

Risk management is undertaken by the Board of Directors.

Credit risk

Credit risk arises from cash and cash equivalents as well as any outstanding receivables. Management does not expect any losses from non-performance of these receivables. The amount of exposure to any individual counter party is subject to a limit, which is assessed by the Board.

The Company considers the credit ratings of banks in which it holds funds in order to reduce exposure to credit risk, which is stated under the cash and cash equivalents accounting policy.

Liquidity risk

Liquidity risk arises from the Company's management of working capital. It is the risk that the Company will encounter difficulty in meeting its financial obligations as they fall due.

i) Financial Risk Management (continued)

Controls over expenditure are carefully managed, in order to maintain the Company's cash reserves whilst it targets a suitable transaction.

Capital risk management

The Company's objectives when managing capital is to safeguard the Company's ability to continue as a going concern, in order to provide returns for shareholders and benefits for other stakeholders, and to maintain an optimal capital structure.

In order to maintain or adjust the capital structure, the Company may adjust the amount of dividends paid to shareholders, return capital to shareholders or issue new shares.

The Company monitors capital on the basis of the total equity held by the Company, being £49,967 as at 31 March 2026 (31 December 2024- £345,798).

j) Finance income

All finance income is accounted for on an accrual basis.

k) Expenses and Finance Costs

All expenses and finance costs are accounted for on an accrual basis.

Operating expenses are recognised in the profit and loss account upon utilisation of the service or as incurred.

Borrowing costs directly attributable to the acquisition, construction or production of a qualifying asset are capitalised during the period of time that is necessary to complete and prepare the asset for its intended sale or use. Other borrowing costs are expensed when incurred and are reported as borrowing costs.

l) Critical Accounting Estimates and Judgements

The Directors make estimates and assumptions concerning the future as required by the preparation of the financial statements in conformity with UK-adopted international accounting standards in conformity with the requirements of the Companies Act 2006. The resulting accounting estimates will, by definition, seldom equal the related actual results.

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances. There are no significant estimates or judgements in these financial statements.
